Communication with I&APs, and Means of Consultation Employed

Regulation 21 of the EIA Regulations details the steps to be taken during a public consultation process and these have been used in guiding this process. Communication with I&APs about the proposed activities was facilitated through the following means and in this order:

- A Background Information Document (BID) containing brief information about the proposed project
 was compiled and hand-delivered to the Ministry of Environment, Forestry and Tourism (MEFT)
 accompanying the ECC application, and uploaded on the MEFT (ECC) Portal for project
 registration and shared with registered Interested and Affected parties (I&APs).
- Project Environmental Assessment notices were published in the New Era and Windhoek Observer newspapers on the 30th of October 2024 and 05th of November 2024. The consultation period ran from the 30th of October 2024 to the 03rd of December 2024.
- EIA posters were pasted in Aussenkehr in early November 2024 (before the consultation meeting) as shown below.

• A consultation meeting was scheduled and held with available I&APs in Aussenkehr on the 20th of November 2024. The meeting was attended by five people. The low meeting attendance was due to the unavailability of most members of the public and some landowners who were busy with grape harvesting in Aussenkehr at the time. The consultation meeting minutes were taken.

Feedback and Issues raised by the Stakeholders (I&APs)

Some key issues were raised by I&APs during the consultation period and these issues have been recorded and incorporated in the ESA Report and EMP. The summarized key issues are presented in Table 1.



The EIA consultation started from the 30th of October 2024 to the 03rd of December 2024. Key comments were submitted to Serja Consultant during consultation meetings as summarized above as also indicated in the meeting minutes.

Feedback on the Draft Scoping Assessment Report Review

For review and further comments, the Draft ESA Report, Environmental Management Plan (EMP) as well as the associated appendices were circulated to the registered stakeholders (through their representative) on the 07th of February 2025 for 14 days for comments before finalizing for submission to the MEFT for evaluation. Due to other commitments from the I&APs which coincided with the mourning period of the Founding President between 08 February until the funeral service on the 01st of March 2025, the draft report review period was extended to 11 March 2025.

Katjavivi takes swipe at absent MPs

ncertainty reigned once more in the National Assembly as no quorum could be established for the tabling of the mid-term budget yesterday.

National Assembly Speaker Peter Katjavivi described the situation as "unbearable" two days in a row. The Speaker also expressed disappointment over the general conduct of parliamentarians, which often results in sessions starting late, and sometimes in important meetings being postponed.

"I expected most of the members to be in the House today. I have expressed my displeasure, and this is something we hope is not repeated," said Katjavivi yesterday during an interview after the session was postponed.

Although a working quorum was met, the quorum of at least 49 parliamentarians was needed for the tabling of legislation, and this was not achieved as the August House needed at least two more members for the tabling of the mid-year budget.

This situation meant that Finance and Public Enterprises Minister, Iipumbu Shiimi, had to wait once more to table the legislation that reallocates revenue to necessary and emergency areas.

He has emphasised that the Mid-Term Budget Review is not a new budget, but only a reallocation of existing resources. As such, the Mid-Term Budget is rather an opportunity for government to reallocate revenue budgeted at the beginning of the year.

Inna Hengari, a Popular Democratic Movement lawmaker, said she was happy that Katjavivi addressed the lack of commitment by parliamentarians.

'There is basically a budget for an entire country that is being held up due to the lack of members," said Hengari, who proposed strict measures to hold Members of Parliament accountable. She added there should also be a clear distinction between ordinary parliamentary members and voting members.

Commenting on the lack of quorum,

Mines and Energy minister, Tom Alweendo, said parliamentarians' behaviours are contrary to the expectations of the public. "If you are a Member of Parliament, then you need to set a good example," he said.

Chantelle Husselmann, country partner at the auditing and tax advisory firm PWC, noted the Mid-Term Budget Review is a necessary exercise not only for the national budget, but also as a regular exercise for businesses and household budgets. She added the budget review provides valuable data in terms of revenue-collection and expenditure

Husselmann further noted that focus is expected on areas of drought relief, as well as boosting social sectors and a potential tax reduction for small businesses.

Meanwhile, the Institute for Public Policy Research (IPPR) said they expected Shiimi to address healthcare, lower taxes, infrastructure improvement and poverty alleviation through a basic income grant.

"Civil society organisations (CSOs) believe the national budget is a powerful tool that can be used more effectively to address systemic poverty, improve living conditions and promote social equity in Namibia," reads an IPPR briefing paper.

The IPPR paper summarises civil society submissions and suggestions regarding budget priorities made to the finance ministry. They further noted that CSOs emphasised the importance of strengthening budget participation mechanisms to enhance government accountability, and ensure effective policy implementation.

Hompa Kaundu threatens to report lazy officers

NCAMAGORO - Safety and security minister Albert Kawana officially inaugurated a police station at Ncamagoro village in Kavango West.

The construction of the prefabricated facility started in February 2023 and was completed in June 2024. It was constructed at a cost of N\$15.6 million.

Kawana said, the government is committed to ensuring that all citizens, regardless of where they reside, have access to essential services.

"The opening of the Ncamagoro police post is a testament to that commitment. It is our belief that no community should be left behind, and that all Namibians deserve the right to live in peace and security, while at the same time having access to highquality public services," he said.

He added that this post is not just a building, but rather a symbol of the government's unwavering dedication to the safety and security of all citizens.

Kawana said the Ncamagoro area, like many rural areas across the country, faces unique challenges. The geographical

remoteness of the region has, for too long, made it difficult for the people to access services, including those provided by the Namibian Police, and this has unfortunately led to an environment where criminal activities thrived.

The structure consists of a charge office, an office block with three offices, barracks for males and females, two twobedroom houses, a recreational area and a septic tank. It is equipped with a borehole. The facility also has a brand-new Toyota Hilux single cab.

"Infrastructure of this nature are a true reflection of the

government's commitment to improving the working environment of civil servants and bringing policing services closer to the people," said the minister. Meanwhile, Hompa Alfons Kaundu of the Mbunza Traditional Authority in Kavango West implored his subjects to report illegal activities to the newly inaugurated police station at Ncamagoro village.

"I want the police officers stationed here to work. I will take the [police] general's number [to call him]. If you are not doing your job, I will call him straight and report you. Don't just come here to get marriedno. If you face challenges, call me; I will assist you. I used to be a soldier, and I want to root out crime in this area," he said.

Kaundu said Ncamagoro village is one of the high crime areas, with livestock theft and gender-based violence cases topping the list. He revealed that many cases of assault taking place in villages are never reported. He further claimed that criminals in Ncamagoro also get away with crimes of housebreaking and throwing objects at moving vehicles along the highway, amongst

"Ncamagoro inhabitants and surrounding villages, you should all collaborate with the police to make policing easy... [and criminals] must repent now because if you don't, that van will get you if you break the law," he noted.

Kaundu then warned community members against walking too close to the road, which has caused many people to lose their lives. He was optimistic that this would change with the establishment of the new police station. Furthermore, the traditional leader implored the community to report shebeen and cuca shops that operate beyond their official closing time as set by law, and warned the community against housing criminals. -jmuyamba@nepc.com.na

he scientific reason behind the fact that most of us are struggling on the first day of the week is called a social jet lag, and the only one to blame is yourself.

Is your mood on Mondays not as good as on the other days of the week and are you having trouble finding your #MondayMotivation because you feel so tired? The scientific reason behind the fact that most of us are struggling on the first day of the week is called a social jet

And the only one to blame is yourself.

This social jet lag is caused by not sticking to the same sleep-wake schedule every day. Staying up late on Friday or Saturday evenings and sleeping in the morning after messes with our internal body clock. You are basically putting your body into a different time-zone over the weekend and pay the price for it on Mondays.

A variation of one hour in your sleeping time won't have any effect but anything more than a two hour difference and your internal body clock can be thrown off by at least 45 minutes. So thinking you could catch up on some sleep during the weekend will leave you feeling even more drained than before. This so

called 'sleep debt' can simply be dealt with by getting around eight hours of sleep every night, which is the recommended amount of sleep for adults, during the next couple of days because the brain rests more efficiently when you are feeling tired. The most effective way to get those eight hours of sleep is to go to bed earlier than you normally would and set your alarm at the usual time. Taking a nap during the day to gain some energy won't help either. Sleeping for too long during the course of the day will keep you up at night. If you really don't want to miss out on those day-time naps, try scheduling them between noon and 4 p.m. and don't let them last longer than 30 minutes so they won't interfere with your sleep at night. If you keep the naps short enough, they even have a lot of advantages. Other things you might want to consider when trying to get your rhythm back on track is drinking less alcohol, banning television-, computer-, and mobile screens right before bedtime, not drinking coffee after 2 p.m., and the most horrible sounding tip of them all: don't dare hit the snooze button. Research has shown that those few precious minutes of extra sleeping time often leave you more tired than if you would have gotten straight out of

Advances and Remaining Challenges in Namibia's Adult Literacy

amibia has made significant strides in improving adult literacy since gaining independence in 1990. Through sustained government efforts and partnerships with various organizations, the country has seen a notable increase in literacy rates. Yet, despite these advances, there remain substantial challenges that need to be addressed to ensure that all adults in Namibia can fully participate in society and enjoy the benefits of literacy.

In the years following independence, Namibia identified education as a key driver of development and equality. The government launched the National Literacy Programme in Namibia (NLPN) in 1992, aimed at reducing illiteracy among adults, especially those in rural areas. This program, which has been largely successful, has helped increase the adult literacy rate from around 65% in the early 1990s to over 89% by recent estimates. The program provided adults with opportunities to gain basic literacy and numeracy skills, empowering them to engage more effectively in economic and social

By continuing to invest in adult education, strengthen partnerships, and innovate in digital learning, Namibia can build on its successes and overcome the remaining barriers to achieving universal literacy. 

1. INTRODUCTION AND WELCOMING

Mr. Stefanus Johannes (Environmental Assessment Practitioner / Consultant) from Serja HGE Consultants opened the meeting and thanked the meeting attendees for making time. Mr. Johannes then presented the meeting agenda, which is based on the requirements of the 2012 EIA Regulations: Environmental Management Act No. 7 of 2007 on Public Consultation' Section 21 to 24.

Copies of the Background Information Document (BID) were distributed among the attendees for self-reading and follow throughout the meeting proceedings. The attendance register was circulated for the attendees to sign the meeting attendance as proof of consultation to be appended to the EIA Scoping Report.

2. MEETING AGENDA AND PRESENTATION

The Environmental Assessment Practitioner (EAP) / Mr. Johannes presented the agenda of the meeting which included the following main points:

2.1 Explanation of what an EIA is, its Process, and the Public Role in the Process

Mr. Johannes explained that the EIA process is done in compliance with the EMA, as the proposed prospecting and exploration works are one of the listed activities that cannot be undertaken without applying and obtaining an Environmental Clearance Certificate (ECC) from the Environmental Commissioner, which is subject to an EIA process and EIA Scoping Report as well as an Environmental Management Plan (EMP). The EIA process requires that the consultation meeting is held with the affected and or interested community members where the project activities would be undertaken.

Furthermore, the EPL is in an application stage with the Ministry of Mines and Energy (MME), which is pending an ECC for decision-making on whether to issue EPL rights or the certificate to New Hope Mining. Therefore, the ECC needs to be obtained first from the Environmental Commissioner at the Ministry of Environment, Forestry & Tourism (MEFT) and submitted to the Mining Commissioner at MME to consider the EPL application/rights approval and issuance.

2.2 Brief Description of the Project

A brief description of the planned project activities was presented as per the provided BID copy, and Mr. Johannes emphasized the importance of understanding that the conducted EIA Study and subsequent ECC are for prospecting and exploration only and not mining (an EPL is exclusively for exploration). This is because mining activities cannot be undertaken on an EPL as a mining license would need to be applied for after successful exploration. In other words, mining can only be considered once the exploration activities yield positive (economically feasible) results, which would mean the Proponent will need to convert the EPL into a mining license which would mean that the Proponent would need to apply for a mining license in the future, if exploration works yields positive results. The mining license would be also subject to another detailed Environmental Impact Assessment (EIA) Study with specialists and apply for an ECC for mining activities. Therefore, it is important to note that the scope of the current EIA is aimed at prospecting and exploration only and not mining.

2.3 Presentation of Potential Project Impacts

To ensure transparency and that the attendees understand both sides of the proposed project activities, Mr. Johannes also presented the potential pre-identified potential positive and negative environmental impacts anticipated from the proposed prospecting and exploration activities. This will establish the basis for mitigation measures to be developed for the proposed exploration activities on the EPL.

2.4 Public Open Discussion (Interactive Session)

The meeting attendees were provided with an opportunity to ask questions and/or raise concerns about the proposed project activities to be incorporated into the meeting minutes and used as the basis for the compilation of the EIA Scoping Report and Draft EMP. The key comments and issues made in the meeting were recorded and noted for consideration and inclusion in the EIA Report. These issues and comments are presented in Table 1.

3. FINAL REMARKS AND CONCLUSION OF THE MEETING

3.1 What is the way forward after this meeting?

Mr. Johannes thanked the community for attending the meeting. He informed them that their comments and recommendations will be included in the EIA Scoping Report and EMP that will be submitted to the Environmental Commissioner at the Department of Environmental Affairs and Forestry (DEAF) of the MEFT for evaluation and consideration of the ECC. However, the drafts of these documents (including meeting minutes) will be first shared with registered I&APs for review and further comments before submission to the MEFT. In other words, once the review of the draft documents by I&APs is completed, the documents will be finalized and submitted to the Environmental Commissioner at the DEAF/MEFT for evaluation and consideration for an ECC.

3.2 What happens after the ECC is approved by the Environmental Commissioner (if approved)?

Once the ECC is issued by the Environmental Commissioner (if approved), probably from March/April 2025, the ECC will be submitted to the Ministry of Mines and Energy (MME) to proceed with evaluating the application for the EPL rights/certificate. After the EPL certificate is issued by the MME, the Proponent would prepare for exploration by first making all necessary arrangements (contractual) such as obtaining land access/use from landowners and obtaining permits such water abstraction. Given the long process associated with EIA document review/evaluation at MEFT before the ECC is granted, these contractual land access agreements and authorizations (water abstraction permit) are anticipated to only start from mid-2025 once all documentation (ECC and EPL certificate) are in place.
