Communication with I&APs and Means of Consultation Employed

Regulation 21 of the EIA Regulations details the steps to be taken during a public consultation process, and these have been used in guiding this process. Communication with I&APs with regard to the project was facilitated through the following means and in this order. Local community/stakeholders' input is essential for the EIA and ultimately the project to ensure the road serves both local and regional development goals.

- A Background Information Document (BID) containing brief information about the proposed project was compiled and hand-delivered to the Ministry of Environment, Forestry and Tourism (MEFT), accompanying the ECC application, and uploaded on the MEFT (ECC) Portal for project registration and shared with registered Interested and Affected parties (I&APs).
- Project Environmental Assessment notices were published in the New Era and Windhoek
 Observer newspapers dated 22 and 28 January 2025 (Appendix C). The consultation period
 ran from the 22nd of January 2025 to the 21st of February 2025. To allow time for comments
 after the consultation meetings in August 2025, the comments were extended to 29 August
 2025 (as indicated on the BID and EIA poster placed in Uis).
- The consultation meetings between key stakeholders (Daure-Daman Traditional Authority (DDTA) and Tsiseb Conservancy) were scheduled and held on the 14th of August 2025 at 10h30 AM and 12h20 PM, respectively (Figure 1 and Figure 2). The meeting minutes are attached hereto as Appendix D. The consent letters issued by the two key stakeholders (DDTA and Tsiseb Conservancy).

Feedback and Issues Raised by the Stakeholders (I&APs)

A few issues and comments were raised by the stakeholders in the meeting as these are as follows:

- The EPL area is a farming area, and there are some communities just outside of the EPL. Or there might be one or two houses inside the EPL, as some people practice a nomadic way of life for their livestock. Therefore, this community will need to be met with later on again and informed of the intended activity in the area. We will notify them to sensitize them in the meantime.
- There are some small-scale miners in the area. Therefore, they should be respected and allowed to mine their semi-precious stones for their livelihood.
- There is an issue of proponents selling their EPLs later without even informing the TA. Therefore, we will need to sign a memorandum of agreement (MoA) once the paperwork has been issued (ECC and EPL certificate). This will also extend to the mining stage by signing another MoA.

- The Proponent should always inform the Traditional Authority and what kind of work will be done in the area and for how long. This is just to encourage and maintain transparency.
- Proponents selling EPLs without consulting or informing the TA is a big concern. Therefore, if the Proponent intends to sell the EPL, the TA should be informed so that the MoA is adhered to (the Proponent and or new EPL owner pays a certain amount to the TA).
- The issue of employment is one of the main concerns for EPLs, where sometimes exploration teams are full of people from outside the area, and doing work that can be done by local people (local people are sidelined for opportunities).
- It is important to consult and inform the community living in the Conservancy near the EPL before exploration starts.
- Based on the positive impacts of the EPL in the Background Information Document (BID), there is a missing point in the payment of fees to the Conservancy. This is because exploration potentially damages some of our flora in the area or habitats for fauna in the Conservancy during exploration. The EPL is close to the Nuinab farm, where livestock are grazing on open land in the Conservancy. Thus, there will be limited grazing land for animals.



Paula Badosa eliminates third seed Coco Gauff

ELBOURNE - Coco Gauff's winning run came to an end against Paula Badosa ▲ in the quarter-finals of the Australian

The American third seed arrived here as the most in-form player on tour after winning the WTA Finals to end last season, and then all five singles matches at the United Cup, including one against Iga Swiatek.

She went into the last-eight tie with 11th seed Badosa on a 13-match winning streak, but it was the Spaniard who came out on top in a 7-5, 6-4 victory. Badosa feared she may have to retire last year because of a persistent back problem, but ended the season strongly, making the quarterfinals of the US Open, and has now hit a new high in Melbourne.

'Today, I came in and I wanted to play my best ame, and I think I did it," she said. "Coco, at the beginning, she was playing insane tennis, but I'm super-proud of the level I gave today.

"A year ago, I was here with my back, and I didn't know if I had to retire from this sport, and now, I'm here playing against the best in the world. I won today, I'm in the semi-finals. I will never think that a year after I would be here."

Both players held serve until 5-5 in the first set, when Badosa struck before opening up a 5-2 lead in the second set.

She was unable to serve it out at the first time of asking, but made no mistake the second time around to set up a clash against either top seed Aryna Sabalenka or Anastasia

Gauff was left to rue 41 unforced errors, but was philosophical afterwards, saying: "Paula was set could have gone my way, could have been a different outcome in the first set.

"I think it's just a lot more work to do. I'm obviously disappointed, but I'm not completely crushed. I'm looking forward to a lot. Even though I lost today, I feel like I'm in an upward trajectory."

Things did not go according to plan for Gauff against Badosa, with the 20-year-old identifying her serve as something that needed a bit more work after six double faults.



Hamilton 'realises dream' on first day at Ferrari

ewis Hamilton says he has "realised his dream" and his first official day at Ferrari marked a "new era in the history of this iconic team".

Hamilton, 40, began his preparations for his debut season with his new team on Monday at the Ferrari factory in Maranello.

The seven-time world champion signed for Ferrari in January last year but contractual commitments to Mercedes prevented any substantive contacts until the end of 2024.

"There are some days that you know you'll remember forever and today, my first as a Ferrari driver, is one of those days," he said in a post on Instagram.

"I've been lucky enough to have achieved things in my career I never thought possible, but part of me has always held on to that dream of racing in red. I couldn't be happier to realise that dream today.

"Today we start a new era in the history of this iconic team, and I can't wait to see what story we will write together."

ERLIN - Joachim Löw is interested in a return to coaching, four years after stepping down as Germany helmsman, preferably at another national team and possibly at the 2026 World Cup.

Sport Bild said in a report published yesterday that Löw, who turns 65 next week, can only see himself as a national team coach, and not in charge at a club at

"If there's one thing I can fall back on, it's a lot of experience at tournaments," he said.

The 2014 World Cup winner struck similar line in an interview with Kicker sports magazine.

"There have been a few offers in the past two years, but I didn't have the feeling that I was burning for it," Löw said.

"But I will look into exciting options. I have experience with national teams, and in preparing a team with a vision over two years for a tournament."

Löw was Germany assistant coach under

Jürgen Klinsmann 2004-2006, and then head coach 2006-2021. He won the 2014 World Cup, reached the final at Euro 2008, came third at the 2010 World Cup, and was a semi-finalist at Euro 2012 and 2016.

His last engagement as a club coach was at Austria Vienna in 2003-04.

Löw admitted in the *Kicker* interview that he should have resigned after Germany's first-ever World Cup group stage exit in 2018 in Russia. "I should have cleared the way for

someone who comes up with new ideas and makes a clear cut with the golden generation," Löw said. He said it took him some time to digest

disappointing results in his final years as Germany coach, but that he was also not in a hurry to return.

"I don't have the pressure of a young coach who always has to move on quickly,"


