- b) A buffer zone of one 100m should be created and maintained around the sacred place and further documentation should be considered.
- c) A buffer zone of 100 m should be created and maintained around the stone circles and rock shelters located within the EPL.
- d) Monitoring and evaluation inspection will be carried out on the area during the course of the year.
- e) Failure to adhere to the conditions will attract fines or imprisonment or the retraction of the consent as per the National Heritage Act no. 27 of 2004.
- f) As per Section 55 (9) (a) the activity authorized by this consent be supervised by a person with appropriate professional qualifications or experience.
- g) The proponent should take caution approaches together with the compliance and of the Chance Find Procedure.
- h) The consent holder is to report back to the National Heritage Council every six (6) months on compliance with the conditions of this consent.


