RECOMMENDATIONS ON THE ENVIRONMENTAL AND SOCIAL IMPACT ASSESSMENT (ESAI) PROCESS FOR THE PROPOSED SEAWEED AQUACULTURE FARM AND ITS ASSOCIATED INFRASTRUCTURE (PONDS, SOLAR PV, 2 WIND TURBINES, WATER SUPPLY PIPELINES AND A PRODUCTION FACILITY), LOCATED IN WLOTZKASBAKEN, ERONGO REGION, NAMIBIA

The Ministry has reviewed the Environmental and Social Scoping Report (ESIA) submitted by I.N.K Enviro Consultants on behalf of Scorpio Alternative Fuels Namibia Pty Ltd, in support of an application for Environmental Clearance Certificate (ECC) for the operations proposed in above subject matter.

The Ministry recommends that an Environmental Clearance Certificate is granted with the below stipulated conditions, as we do not foresee adverse environmental impacts from the proposed activities

- The use of veterinarian drugs and their residues on the seaweed and their feed must align to national laws and international Codex Alimentarius standards to ensure food safety and prevent health risks from harmful residues.
- 2. Sources of the stock of aquatic organisms for cultivation, is subjected to veterinary import permit and all necessary documentations.

- 3. Staff members from the relevant competent authorities must be granted access to conduct site visits to inspect the projects operational processes periodically and / or as the need arises.
- 4. Hard copies of environmental monitoring reports must be submitted to the Ministry of Agriculture, Fisheries, Water and Land Reform (MAFWLR), Directorates Marine Ecosystem and Fisheries Research (DMEFR) and Aquaculture and Inland Fisheries (DAIF) on a six-month basis.
