# **NEFF** irked by campaign material removal

UNDU – The Namibian Economic Freedom Fighters (NEFF) have voiced dissatisfaction with the Rundu Town Council for removing their campaign posters from street light poles around the town.

NEFF spokesperson Teresia Hamurenge told Nampa on Monday that all posters belonging to NEFF, the Landless People's Movement and the Popular Democratic Movement were removed because the parties have not paid council fees.

"The only posters that were not removed belong to the Independent Patriots for Change (IPC) and Swapo. We have to, apparently, pay N\$159 per pole if we want to put posters on the poles," she said.

She stated that the town council should

have informed the political parties about the required payment prior to removing

She said they had invested a lot of money in the posters.

"If we had been informed earlier, like through a public notice, we would have paid. Many towns, such as Windhoek, don't charge us or remove posters," she

She said her party had requested to see the gazetted tariffs, but claimed the council had not provided it.

In response, Rundu Town Council CEO Olavi Nathanael said advertising space on poles is a paid service, and political parties are not excluded from this.

He added that political parties, or any other interested party, must first apply if they wish to use the poles for advertising.

"You don't just put things up without our consent. Everybody else applies, and then we give you an invoice," he noted.

He said Swapo and IPC paid to display

"Everyone, including political parties wishing to do outdoor advertising, whether through free-standing units or poles, pays the necessary charges as per gazetted tariffs," he remarked. -Nampa

## PDM promises Kavango transformation

RUNDU - Popular Democratic Movement (PDM) leader and presidential hopeful McHenry Venaani has promised to change the fate of Kavango inhabitants once elected into power.

He said no life will be lost due to crocodile attacks while people fetch water.

He promised that he would improve the water infrastructure in the two regions.

"Brothers and sisters, the government of the day has failed us. They have failed us on water. They have failed us in sanitation. They have failed us in healthcare. The PDM plans to ensure that every family has access to proper sanitation in their communities through their 'One Family, One Toilet' initiative.

He said they will reduce the spread of diseases, ease the burden on the healthcare system, and restore dignity to people.

"This is not just an election promise. It is a commitment to the health and well-being of every Namibian. Furthermore, we cannot overlook the intolerable burden on our healthcare system, especially in these regions, when discussing healthcare. Namibia's healthcare system is in danger of failing," he stated.

## Prison term set aside in drugs case

A //KHARAS region farmworker who was sentenced to a prison term of 18 months after he admitted that he possessed cannabis and mandrax valued at N\$8 500 has won an appeal against his sentence.

The magistrate who sentenced Donovan Kooper in the Bethanie Magistrate's Court in February this year did not carefully consider Kooper's personal circumstances, judge Philanda Christiaan said in an appeal judgement delivered in the Windhoek High Court on Monday.

"In my view, the court overemphasised the seriousness and prevalence of the crime at the peril of [Kooper's] personal circumstances," Christiaan remarked.

"To impose an effective 18 months' imprisonment on a first-time offender who tendered a plea of guilty and who was gainfully employed is in my view too harsh. The court indeed paid lip service to the consideration of mercy or leniency," the judge added.

Kooper admitted guilt on a charge of possession of prohibited dependence-producing substances in February this year.

He admitted that he had 142 grams of cannabis, valued at N\$1 420 and 59 mandrax tablets containing the prohibited substance methaqualone and valued at N\$7 080, in his possession at Bethanie in the //Kharas region on 5 January 2022.

Following his arrest, Kooper spent five months in police custody before he was released on bail.

Magistrate Mulonda Masuku sentenced him to 18 months' imprisonment, without an option to pay a fine and with no part of the sentence suspended, after Kooper admitted guilt on the charge.

After defence lawyer Percy McNally informed the magistrate that Kooper had the cannabis and mandrax tablets in his possession for his own use, Masuku commented that in his view, Kooper needed to be rehabilitated from his drug addiction.

McNally also informed the court that Kooper, then 31 years old, was employed as a goatherd and is the father of four children.

In the appeal judgement, Christiaan concluded that the sentence of 18 months' imprisonment was excessive.

She set aside the sentence and replaced it with a fine of N\$3 000 or six months' imprisonment, with the new sentence suspended for a period of five years on condition that Kooper is not convicted of possession of a prohibited dependence-producing substance during the period of suspension.

Christiaan also ordered that Kooper should be released from custody without delay, unless he is lawfully detained on other charges.

Judge Herman January agreed with Christiaan's decision.

# Naval base proposed for Kunene River

A PARLIAMENTARY standing committee has proposed the creation of a naval base at the Kunene River.

The National Council standing committee on agriculture, environment and natural resources says this is to combat illegal, unreported and unregulated (IUU) fishing.

In a report released by the committee and signed by chairperson Melania Ndjago, the members say they have engaged with stakeholders to understand issues in the area.

This proposal follows concerns raised in the report issued last month by the committee on its oversight visit to investigate the status of Namibia's fishing resources.

The report highlights Namibia's vulnerabilities to IUU fishing activities and systemic challenges within the Ministry of Fisheries and Marine Resources.

The oversight visit included inspections at the ministry's offices at Walvis Bay and Lüderitz, as well as harbours and patrol vessels used for monitoring Namibian waters.

The establishment of a naval base at the Kunene River is viewed as essential for improving response times and surveillance along Namibia's northern waters.

Currently, patrol resources are stationed at Walvis Bay, which is too distant to act swiftly in emergencies.

"Illegal fishing vessels can operate undetected for extended periods because our patrols are limited by distance and outdated equipment," the report says.

It says a Kunene base, equipped with helicopters, drones and modern patrol vessels, could reduce response times from up to a day to as little as two hours.

The report highlights the shortage of personnel within the ministry.

It said the ministry has only 174 fisheries inspectors and navigation officers employed nationwide. They also discovered that fisheries ministry's equipment is strained.

It says only one of two patrol aircraft is operational and that two patrol vessels, though well-maintained, are constrained by high operational costs.

Additionally, all patrol vehicles at Walvis Bay were found to be non-operational.

Illegal activities including mussel harvesting and large-scale fish poaching remain rampant along the coast. These gaps have allowed offenders to exploit Namibia's resources freely, ministry officials have admitted.

Namibia's fishing industry, the country's second-largest foreign currency earner after mining, contributes 4,6% to its gross domestic product and provides employment for approximately 16 000 Namibians.

To combat these challenges, the committee recommended increased funding from the Ministry of Finance and Public Enterprises to support surveillance operations.

Investment in helicopters, drones, patrol vehicles and improved internet connectivity were deemed critical for effective monitoring.

"Without a unified approach, we will continue to lose valuable resources to IUU fishing and-mismanagement," the committee warns.

# Govt yet to announce green scheme bid winners

THE Ministry of Agriculture, Water and Land Reform is yet to announce the winner of the tender to manage the Ndonga Linena green scheme.

Bids were submitted in 2022.

The scheme two years ago requested the Kavango East Regional Council to pump over N\$80 million into the irrigation farm.

Ndonga Linena Agri Foods director Leon Tjihero says the ministry has, however, failed to pronounce the green scheme's status and to provide feedback on a bid winner.

"Bidding closed on 16 December 2022. We hoped to get a response, so we wrote a letter to the ministry in July. The ministry responded after seeking legal advice from the attorney general," he says.

Tjihero says Ndonga LinenaAgriFoods aimed to create jobs, support smalland medium-scale farmers and provide training.

"What are the legal issues the attorney general's office cannot resolve or inform us about as investors? Why should it take so long to give us feedback?" he asks.

Tjihero says the green scheme is not satisfied with the ministry.

Ministry spokesperson Regina Valombola says green scheme projects aim to boost agricultural production and attract both private and public sector investment to ensure food security and self-sufficiency.

Valombola says the min-

istry prepared 700ha of land at Ndonga Linena for the production of summer crops such as maize this month.

This reflects a strong commitment to maintaining agricultural productivity while finalising the lease agreement between the ministry and a successful bidder, she says.

"Currently, the green schemes are funded by the government. Therefore, the ministry's priority is to ensure Namibia becomes self-sufficient by focusing on producing what we consume locally," Valombola says.

President Nangolo Mbumba visited Kavango East and West regions' greenschemes last Wednesday to familiarise himself with progress amid the country's severe drought.

He urged them to produce more to mitigate food scarcity.

During his visit, farm managers highlighted the challenges they are faced with, such as crop theft, high electricity bills, a lack of equipment and fence boundaries being vandalised.

"We cannot continue begging for food from other nations. Therefore, we should repair the machines or replace them to produce food. We have enough land to farm on and to expand the current green schemes," Mbumba said.

He emphasised strong cooperation between regional leaders and green schemes to produce more than expected.

# PDM confronts stock theft, water scarcity

he president of the Popular Democratic Movement (PDM), McHenry Venaani, is concerned about the increase in the incidents of stock theft and water scarcity, specifically in the Omaheke region.

Venaani said this at a recent PDM rally in Gobabis. He said once elected into power, his government will be committed to addressing these issues – not only in Omaheke, but in Namibia at large.

He stated that the rising tide of livestock theft poses a great threat to farmers, who last year lost animals worth N\$3.4 million in the Omaheke region alone.

"This is an affront to our agricultural sector and livelihoods of those who depend on it," Venaani said. Between 2022 and 2023, close to 1 200 cases of livestock theft were reported to the police countrywide.

Omaheke region recorded 225 cases, and Otjozondjupa had the highest number of incidents totalling 451 cases.

This places the two regions on top of the chart of regions with the highest cases of stock theft in the country. The opposition leader, who is also a commercial farmer in the region, stated that the PDM government will be resolutely committed to addressing crime in its all forms.

"We will ensure that our communities can feel safe and secure. We shall enhance the training of police officers to ensure that investigations result in successful convictions," he said.

Venaani added that his government will decentralise policing powers from national to regional and local authorities.

He emphasised that water scarcity is a critical issue that his government will confront "headon". "We are striving for the green revolution. We will invest in sustainable practices that protect our water resources. We will ensure that all citizens have access to clean water," he said.

Venaani said the PDM regime will build a desalination plant along the coast with a water supply line for Namibia's interior, and guarantee consistent access to water for farming.

The PDM leader also promised to

build earth dams in every village and settlement across the country, as they are currently under water stress.

"We will install water points within 100 metres of settlements, particularly in areas where humanwildlife conflict is likely to

occur," he revealed.

He said this would help and guarantee

convenient access to drinkable water, and reduce human-wildlife conflict.

He then called on party members not to lose hope despite the existing challenges.

"We must be steadfast in our conviction to usher in change. We stand at a crossroads, presented with a golden opportunity to send a clear message to the Swapo-led government that it is no longer business as usual – come 27 November 2024," he said.

He added that PDM will no longer standidle while malfeasance, greed, graft, corruption and maladministration undermine democracy.

"Together, we will be able to forge a new path for Namibia. The PDM stands ready to usher in this new era in our country's history," he stated.

He said the party is committed to ensuring that the government serves the people, and not the other way around.

Heremarked that PDM possesses the political maturity, dexterity and experience to take over the reign of government.

"We must reject the ruling party in its entirety. We must break the cycle of malfeasance, maladministration and corruption as we build a better Namibia for ourselves and future generations," he said. He noted that the first step in realising a better Namibia is through voting for PDM on election day, as well as him being voted as the country's president.
