4. Management Experience

Since completing my studies in 1996 as a Town and Regional Planner, I was appointed in a management capacity after returning to the National Remote Sensing Center where I supervised 6 staff. As a result of my performance, I was appointed as acting deputy director of planning in the Directorate of Forestry in the Ministry of Environment and Tourism.

I resigned while in this post to follow a professional career in Town and Regional Planning at the City of Windhoek. At the City, I was appointed as the divisional manager where I was in charge of the Sustainable Development division overseeing 5 staff reporting to the Strategic

Executive Planning and where I was exposed to dealing with the Chief Executive Officer and municipal councilors.

I resigned from this post to be employed as the Executive Manager for Oranjemund Town Management Company (OTMCo), a company wholly owned by Namdeb. As the Executive Manager I was responsible for overseeing the operations of the town, but especially for facilitating and expediting the proclamation of the town. I reported to the Board which was composed of the Managing Director, the Financial Manager, and Business Development Manager of Namdeb, and three community representatives namely the Regional Councilor, the Union Representative, and a representative of the local of the NCCI.

When Oranjemund was proclaimed as a town and local authority councilors were elected, my position became redundant, and I elected voluntary retrenchment as an employee of OTMCo. I then followed my passion in town planning by opening Harmonic Town Planning Consultants overseeing between 6 to 9 staff depending on the work in the office.
