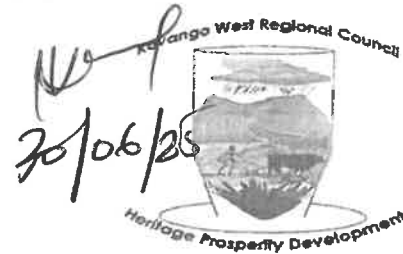
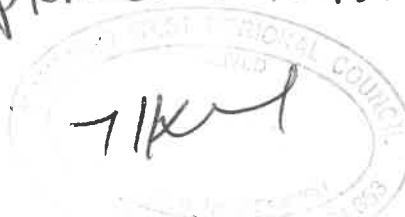

RE: **CONSTRUCTION OF SIKO – GCARUHW A ROAD**



Reference is herewith made to the above-mentioned subject matter.

On the 26th of June 2025 a meeting was held between the Constituency Councillors, Management Committee for Maurus Nekaro Conservancy, a Member of Ukwangali Traditional Authority Council, representative of both Gcaruhwa and Siko villages on the commune received through the Director of Planning and Development Services to seize Siko - Gcaruhwa road.

After a lengthy discussion, a meeting reached a consensus that the construction of the Siko – Gcaruhwa Road should proceed as planned due to fact that the road project was initiated before the establishment of Maurus Nekaro Conservancy. Therefore, Maurus Nekaro Conservancy agreed to provide a consent letter to the consultant of the Environmental and Social Impact Assessment to proceed with the road project.
