PUBLIC CONSULTATION MEETING MINUTES:

ENVIRONMENTAL SCOPING ASSESSMENT (ESA) FOR THE PROPOSED PROSPECTING & EXPLORATION ACTIVITIES ON EXCLUSIVE PROSPECTING LICENCE (EPL) No. 10031 LOCATED WEST OF KHORIXAS, KUNENE REGION.

Date: Thursday, 20 November 2025

Time: 12:00 – 13:00

Venue: Swartbooi Traditional Authority Office, Kunene region

The public consultation meeting was attended by about twenty people, including one (3) Environmental Consultant and one (1) Archaeologist from Excel Dynamic Solutions (Pty) Ltd (EDS) - **Please refer to the attached attendance register.**

1. INTRODUCTION AND WELCOMING REMARKS

The meeting was opened by the environmental consultant with an introduction of the team, who they are, and why they are consulting affected parties of the proposed prospecting and exploration activities on EPL 10031. The meeting attendance register was then circulated for the attendees to write down their names and contact details so that they could be added to the list of interested and affected parties (I&APs) and receive further information on the ESA process.

2. MEETING AGENDA AND PRESENTATION

The agenda of the meeting included the following main points:

2.1 Brief Description of the Project

The Environmental Scoping Assessment (ESA) and the reason that the Proponent appointed Excel Dynamic Solutions (Pty) Ltd (EDS), an independent Environmental Consultant to carry out the ESA and apply for the Environmental Clearance Certificate (ECC).

2.2 Explanation of what an ESA is, its Process, and the Public Role in the Process

Mr. Angula explained to the attendees the purpose of the meeting and why they were invited (with reference to the Environmental Management Act (EMA) No. 7 of 2007 and its 2012 Environmental Impact Assessment (EIA) Regulations on Public Consultation). Mr. Angula further explained what an ESA is and that the proposed exploration activities are one of the listed activities in the 2012 EIA Regulations of the EMA that cannot be undertaken without an ECC from the Environmental Commissioner.

2.3 Presentation of Potential Project Impacts

To ensure transparency and that the attendees understand both sides of the proposed project activities, the Environmental Consultants also presented the potential pre-identified potential positive & negative environmental and social impacts.

2.4 Public Open Discussion (Interactive Session)

Mr. Angula allowed the meeting attendees to raise their concerns, issues and/or comments on the proposed project activities. The concerns/issues and comments recorded are presented in **Table 1** below.

1.	<p>Commenter 1</p> <p>You touched on employment, what type of agreements can be put in place to ensure the community receives these benefits?</p>	<p>Mr. Wilbard Angula (WA): The EIA does not provide for formal employment agreements; however, it recommends that priority be given to local employment. Employment opportunities and other community benefits can be negotiated between the Proponent, the Traditional Authority, and the community, either through a Memorandum of Understanding (MoU) or an Access Agreement.</p>
2.	<p>Commenter 2:</p> <p>Is it possible to get training on these different kinds of licenses because we have small scale miners here?</p> <p>There are small-scale miners already operating in the areas that this EPL overlies. We request that the proponent consider these miners and possibly give them consent to apply for claims.</p>	<p>Ms. (WA): Our company was offering free training earlier this year. I will inquire about the possibility of arranging similar training sessions next year and communicate the outcome.</p> <p>Mr. Wilbard Angula (WA): The presence of existing small-scale miners is noted.</p>
3.	<p>Commenter 3: Our grazing areas are already not up to standard; we barely get rain late here.</p>	<p>Mr. Wilbard Angula (WA): This concern is noted. As part of the ESA process, we will assess the hydrology of the area using relevant maps and data. All environmental factors will be considered and addressed in our reports.</p>

Comment/ issue No.	Commenter name & issue/comment/question	Response and name of responder:
4.	Commenter 4: The //Huab conservancy has areas mobile with rhinos, Does the EPL fall within those zones.	Mr. Wilbard Angula (WA): The conservancy game management & Utilization plan (GMUP) will indicate if the EPL falls within those areas.
5.	Commenter 6: Are you also going to consult the farmers whose farms are within the EPL but aren't here today?	Mr. Wilbard Angula (WA): Yes, we have been informed by some local residents that certain farmers experience transport challenges, and that the meeting venue is relatively far. However, following the meeting, our team will conduct farm-to-farm visits to ensure that all affected parties are adequately informed and given the opportunity to provide input.

FINAL REMARKS AND CONCLUSION OF THE MEETING

Mr. Wilbard Angula thanked the attendees for their crucial input through comments and raising their concerns. He indicated to the attendees that all their comments, concerns, and inputs had been noted down for consideration and addressing in the Environmental Scoping Assessment (ESA) Report as well as incorporating their recommendations into the draft EMP.

Furthermore, Mr. Wilbard Angula informed the attendees that the draft meeting minutes, Environmental Assessment Report, and Environmental Management Plan (EMP) will be shared with them for review and further comments. These documents will be made available through emails provided on the attendance register.









