All domestic waste, such as kitchen refuse, cans, bottles, and paper, will be collected in labelled waste bins. Non-biodegradable waste will be transported to the nearest approved landfill site, while biodegradable waste will be composted where feasible.

3.1.2 What **industrial waste** will be generated and what will you do with it (e.g. old machinery, vehicles, building rubble, batteries, paint, thinners, vehicle oil, etc.)?

Used oil, filters, batteries, tyres, and scrap metal will be safely stored in designated containers and disposed of through licensed recycling or waste management companies. Any old machinery or building rubble will be removed from the site upon completion of operations.

3.1.3 Describe what type of **toilet facilities** will be provided.

Portable chemical toilets will be provided and maintained on a regular basis. Waste will be safely removed by authorised service providers to avoid groundwater contamination.

Vehicle movement will be limited to marked tracks and designated working areas to prevent unnecessary soil erosion and vegetation loss.

Existing roads and tracks will be used. No new permanent roads will be constructed unless absolutely necessary and approved by the relevant authority.

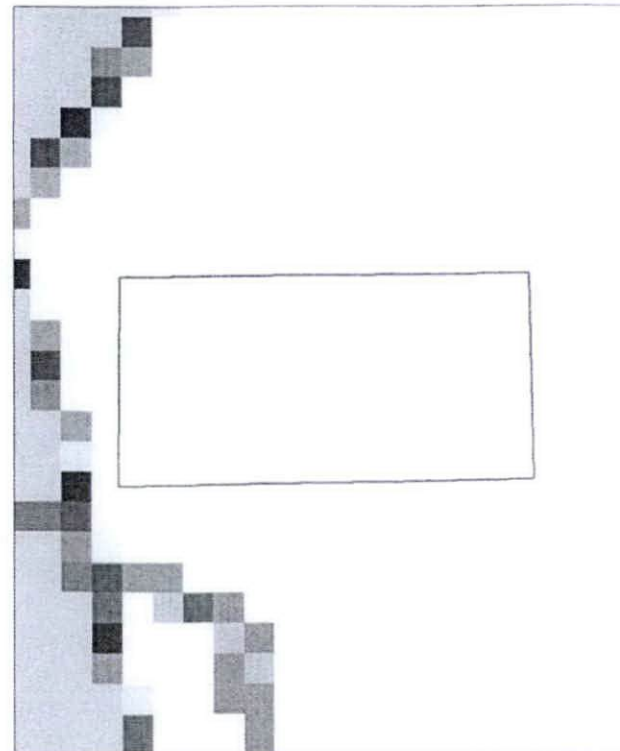
