PORTAL ERROR

- 4. This application is an application for the renewal of the existing Environmental Clearance Certificate currently held by **Desert Storage CC**, which was issued by the Ministry of Environment, Forestry, and Tourism on **15 September 2022**.
- 5. When we applied for the renewal of the Environmental Clearance Certificate on behalf of our client, **Desert Storage CC**, on the MEFT Portal, our office clearly stated that this is an application for the renewal of an existing Environmental Clearance Certificate. It must also be borne in mind that the MEFT Portal does not provide an express option to indicate whether an application is either new or whether the application pertains to the renewal of an existing Environmental Clearance Certificate.
- 6. Despite this, our office clearly delineated that this application was for the renewal of an existing Environmental Clearance Certificate.
- 7. After the preliminary documentation, which was submitted and uploaded on the MEFT Portal, a notice was sent by MEFT to our office listing the documentation which must be submitted in support of the application. This notice is commonly referred to as the Screening Notice.
- 8. Based on the documents requested in terms of the Screening Notice it is clear that MEFT and the MEFT Portal deem this application as a new application, rather than viewing it for what it is, the renewal of the existing Environmental Clearance Certificate held by **Desert Storage CC**. Documents such as newspaper advertisements, correspondence with Interested and Affected Parties, and the Environmental Impact Assessment Scoping Report, were amongst the documents requested. However, all of these documents were submitted during the submission of the original application for the renewal of the Environmental Clearance Certificate, and bears no reference in respect of the current application, being the renewal of the existing Environmental Clearance Certificate held by our client, **Desert Storage CC**.
- 9. Therefore, we kindly request that this misconception and error be rectified immediately.

- 10. Please note that we herewith kindly request that this application receives your urgent and immediate attention.
- 11. Our client has to unload a vessel, and the vessel cannot be unloaded unless our client is in possession of an Environmental Clearance Certificate.
