Dear Sir/Madam

EPL 10405 – PRE-IDENTIFIED POTENTIAL IMPACTS

The meeting at Kombat Lodge on 17 November 2025 at 10h00 refers.

As discussed and pointed out, for any stage of the process to start either prospecting or exploration activities I have following points that need to be adhered to:

1. Consultation/arrangement of time frame for activities on Farm Askevold and Naueis, need to be done well in advance. (Hunting outfit and rainy season)
2. The Proponent will be held accountable/liable to damages of roads, fences and gates.
3. NO accommodation or camping on farms.
4. Important: Sewage and any waste need to be taken care of accordingly.
5. NO employees recruited from direct surrounding/area.
6. ID's of employees need to be presented.
7. Reporting via what's app or SMS when entering farm for any activity taking place.
8. Agreements/Contracts need to be discussed and signed by all parties involved before commencement of any activities, being prospecting or explorations.
9. These agreements/Contracts will be only valid for 6 months at a time, with option of reviewing and extension.
10. Compensation Payments need to be discussed and documented in agreement/contract.
11. These payments need to be done prior to activities, proof thereof.
12. In case bush fires destroy grazing, the Proponent will be held liable and compensation will be charged.
13. Upon completion of activities or termination of agreement, the Proponent will be responsible for rehabilitate and restore the surface of the property.
14. In case a borehole/s was drilled for water to use for activities by Proponent, it becomes the property of farm owner, after Mining activities are ceased.

These are our main points that should be taken into consideration when drafting documents.
