Dear Esteemed Interested & Affected Party,

Yongsheng Lithium Industry (Pty) Ltd (The Proponent) proposes to undertake prospecting and exploration activities on **Exclusive Prospecting License (EPL) No. 10103 located 14 km north of Kombat, Otjozondjupa Region.**

Mineral prospecting and exploration is one of the listed activities that cannot be undertaken without an Environmental Clearance Certificate (ECC) as per the 2012 Environmental Impact Assessment (EIA) Regulations of the Environmental Management Act No. 7 of 2007. The Proponent, therefore, appointed Excel Dynamic Solutions (Pty) Ltd, an independent Environmental Consultants firm to conduct the required Environmental Scoping Assessment (ESA) process and apply for the ECC.

Furthermore, Sections 21 to 24 of the EIA Regulations require that Public Consultation is undertaken as one of the crucial components of the Environmental Assessment, which involves the pre-identification of potential Interested & Affected Parties (I&APs) or Stakeholders and ongoing registration of new I&APs and subsequent consultation. You have therefore been identified as a potential I&AP for this proposed activity, and the reason you are receiving this communication.

Please find the attached Background Information Document (BID) the proposed prospecting and exploration activities.

The EPL covers multiple farms, including: Sumas No.2026, Sumas West, Keilberg No.1371, Auros No.1372, Block No.648 and Gauss No.46
