This email serves to inform you that Excel Dynamic Solutions (Pty) Ltd (the consultant) has been appointed by Tjikunda Katjina Kulunga (the proponent) to act on their behalf in obtaining an Environmental Clearance Certificate (ECC) for the proposed mineral exploration activities on Mining Claim (MC) No. 73444 Located northwest of Okanguati, Kunene Region.

Mineral prospecting and exploration are listed activities that cannot be undertaken without an Environmental Clearance Certificate (ECC) as per the 2012 Environmental Impact Assessment (EIA) Regulations of the Environmental Management Act No. 7 of 2007. 
