

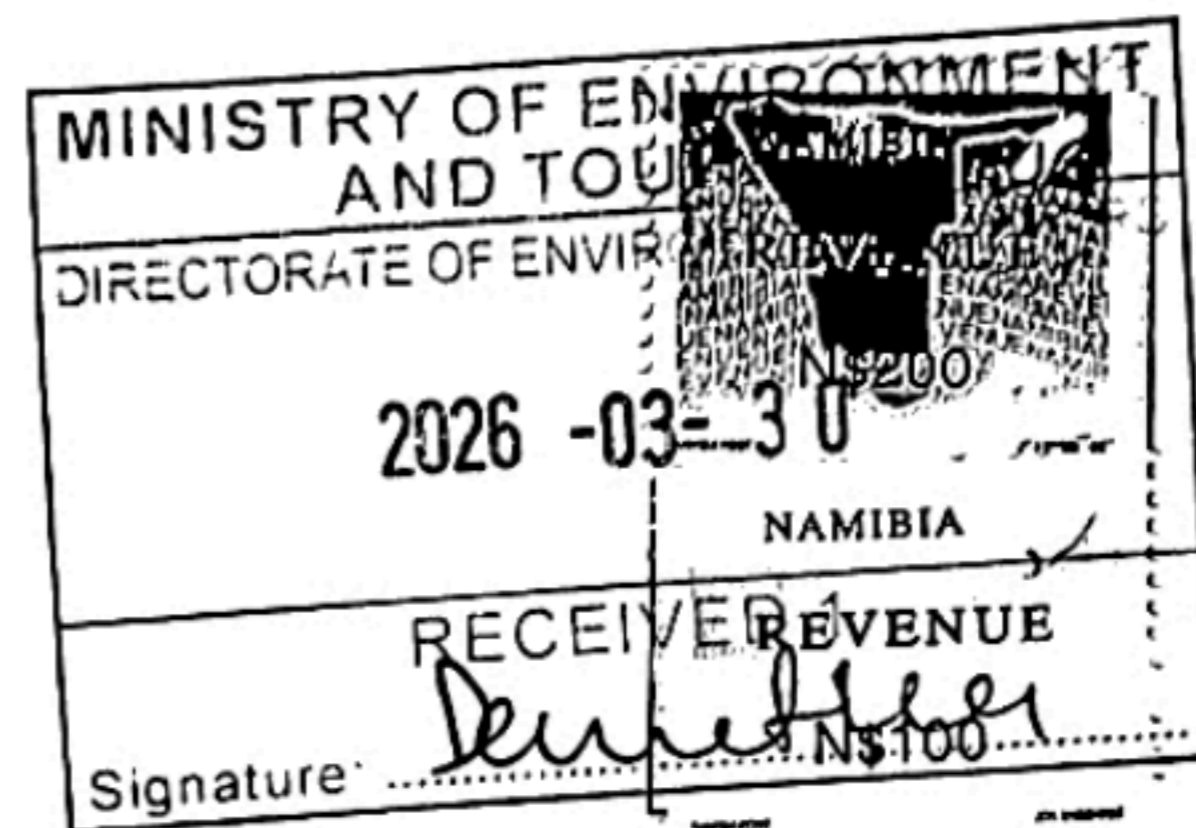

SCALE AND SCOPE OF ACTIVITY: **Power line Route:** The construction of an approximately 7 km long, 33kV overhead power line from the existing Otjiwarongo Substation to a new transformer yard on Farm Drukwerk No. 13.

Infrastructure: Installation of steel pylons, a new switching station at the point of connection, and a transformer on the farm premises.

Electrification: The internal electrification of key farm facilities, including the farmhouse, worker housing, dairy/processing plant, and irrigation pumps.

Construction: Activities will include pylon foundation excavation, tower erection, conductor stringing, and civil works for substations. Construction is anticipated to last 30 days.
