Re: Environmental Scoping Assessment and Environmental Management Plan for the Harvesting of the White Mussel, *Donax Serra*, along the Namibian Coastline, North of Lüderitz

Citygate Trading CC (the Proponent) holds a harvesting right for white mussels (*Donax serra*) along the Namibian coastline, south of Sandwhich Harbour to the Orange River Mouth. The Proponent however decided to focus on a smaller area on the northern-most coastline of the Tsau //Khaeb (Sperrgebiet) National Park, 30 km north of Lüderitz (Figure 1). Harvested mussels will be transported to Lüderitz where they will be received at the Proponent's processing facility within the designated mariculture area. The facility is used for the reception, depuration and packaging of seafood, mainly for export to international markets.

Citygate Trading CC appointed Geo Pollution Technologies (Pty) Ltd (GPT) to undertake an environmental assessment for the harvesting operations, establishment of a temporary workers camp in the Sperrgebiet, and the operation of the Lüderitz processing facility. This assessment is required to support an application for an environmental clearance certificate (ECC) in terms of the Environmental Management Act, Act No. 7 of 2007 (EMA). A scoping environmental impact assessment (EIA) report and an environmental management plan (EMP) will be submitted to the Ministry of Environment, Forestry and Tourism, Office of the Environmental Commissioner, in support of the ECC application.

Project: Harvesting of the White Mussel, *Donax Serra*, along the Namibian Coastline, North of Lüderitz

Proponent: Citygate Trading CC

Environmental Assessment Practitioner: Geo Pollution Technologies (Pty) Ltd

Mussel harvesting will be conducted by hand during low tide, with only mussels meeting the Ministry of Agriculture, Fisheries, Water and Land Reform (MAFWLR) size requirements retained. Access will be by four-wheel drive vehicles. To support operations, a temporary tented camp will be established at the harvesting area to house harvesting teams. The camp will be fully dismantled after use, leaving no permanent impact.

Harvested mussels will be transported to Lüderitz, where they will be received at the Proponent's processing facility in the designated mariculture area. At the facility, mussels are depurated in seawater treatment systems, packed in insulated containers with ice, and prepared for export to international markets. The facility includes storage, packaging areas, offices, and ablutions, with firefighting, safety, and environmental measures implemented according to accepted standards.

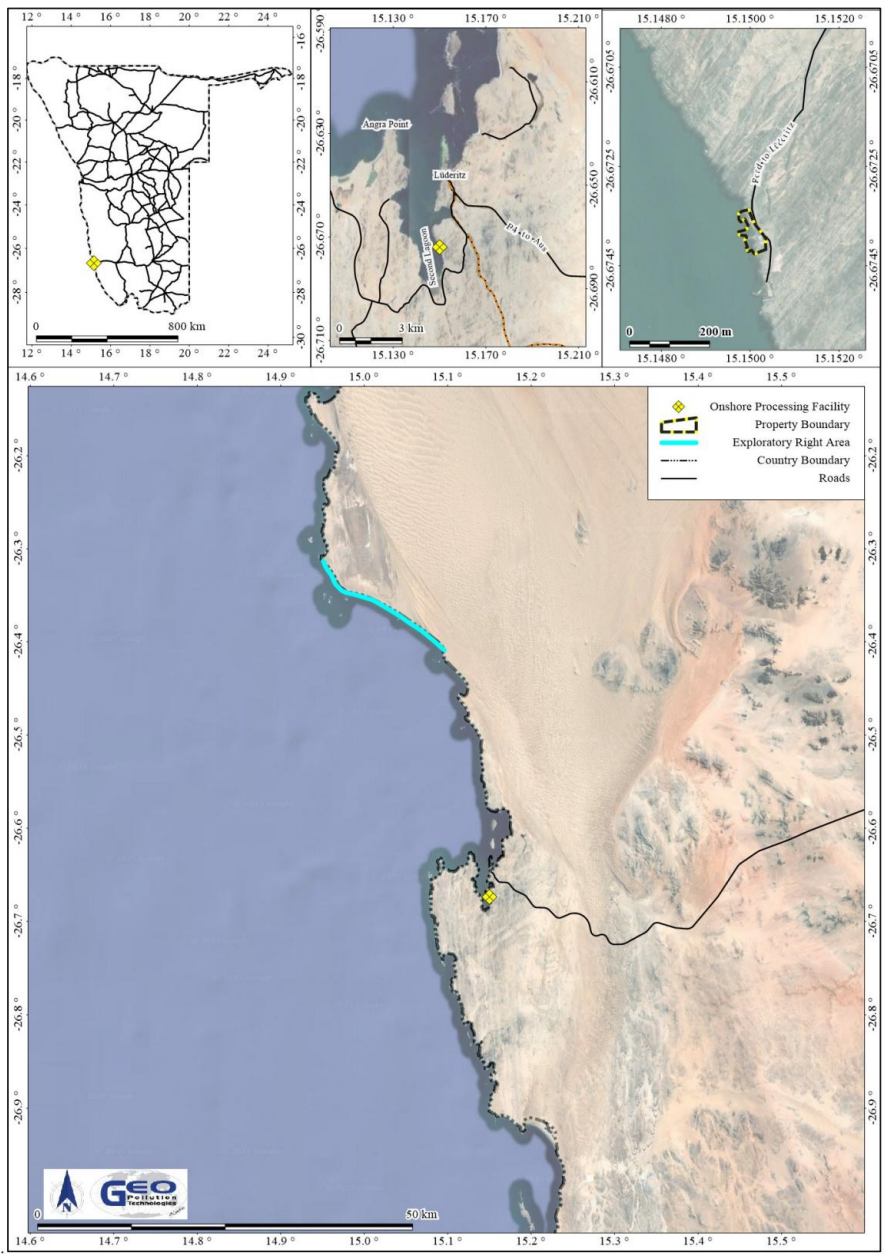
