

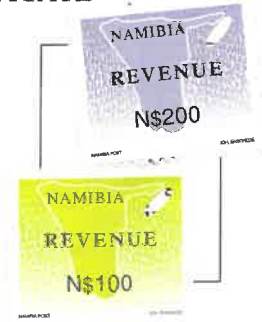

CONTINUED OPERATION OF EKUKU SERVICE STATION IN OSHAKATI, OSHANA REGION**Nature of Activity:**

- The nature of the operation for the Ekuku Service Station is essentially industrial-retail hazardous material management. While customers see it as a convenient place to buy fuel and snacks, the Environmental Management Act (EMA) views it as a continuous cycle of transporting, storing, and dispensing volatile chemicals that pose a permanent risk to the environment.

Location of Activity:

- **Oshakati, Oshana Region, Namibia**

Scale and Scope of Activity:

The scale is considered **Small to Medium** in terms of physical size, but **High-Risk** in terms of environmental sensitivity.

- **Physical Footprint:** Typically confined to a specific plot (usually less than 1 hectare), comprising the forecourt, underground storage tanks (USTs), convenience store, and wash bay.
- **Storage Volume:** The scale is measured by the cumulative capacity of the fuel tanks. If the station stores more than **30 cubic meters** (\$30,000\$ liters) of fuel, it triggers more rigorous monitoring under the EMA.
- **Temporal Scale:** The activity is **long-term and permanent**. Unlike a construction site that clears out, a service station operates 24/7 for decades, meaning the "scale" of the risk accumulates over time (e.g., slow-leak detection).

The scope includes all activities within the property boundaries:

- **Fuel Handling:** Offloading from tankers, storage in USTs, and dispensing to customers.
- **Waste Management:** Disposal of hazardous sludge from oil-water separators and general waste from the retail shop.
- **Resource Use:** High consumption of municipal water (especially if there is a car wash) and electricity.




We wish to bring to your attention specific administrative challenges regarding this renewal. ECC01778 was last renewed on 7 December 2021 and subsequently expired on 7 December 2024. Although the Proponent proactively appointed an Environmental Assessment Practitioner (EAP) on 7 November 2024 to initiate the renewal, the previous consultant failed to deliver the required services and has since absconded.

Consequently, the Proponent has been left without access to the previous application documents or the portal login credentials associated with the expired certificate. This has resulted in the ECC being lapsed for over a year despite the Proponent's best efforts to remain compliant.

In light of these circumstances, we humbly request your office to grant **Envirodu Consulting & Training Solutions cc** authorization to create a new application for this facility on the EIA portal. This will allow us to upload current monitoring reports and the revised ESMP to regularize the environmental standing of the Ekuku Service Station.
