All correspondence should be addressed to the office of the Chief Executive Officer

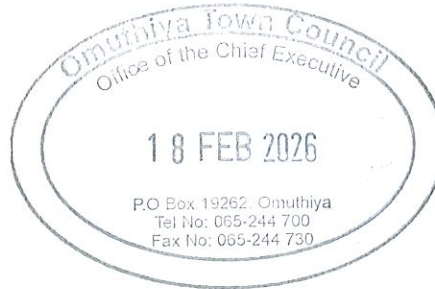
- Authorizes the administration to proceed with all further statutory and administrative processes necessary to give effect to the township establishment and subsequent allocation of erven.
