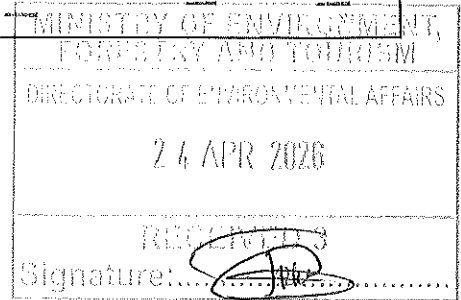

### **2.4 Scale and Scope of the Activity**


The scale of the project is medium:
