### 2.4 Scale and Scope of the Activity


The scale of the project is considered medium and are as follows:

- Once the target areas have been selected and verified under the prospecting phase, detailed exploration works (drilling) will follow the project resources and detailed management action are presented in the EMP herewith attached.
